The Association activity is carried out from a perspective of transparency, independence, objectivity and a neutral stance.

ISMS Forum Spain has more than **750 members** and **100 companies associated**. Therefore, the Association is already the largest active network of experts and organizations engaged with Information Security in Spain.

The ISMS Forum organizes its activity through different initiatives: The International Conferences, the Spanish Cyber Security Institute (SCSI), Data Privacy Institute (DPI), Cloud Security Alliance Spain (CSA-ES), the portal Protegetuinformacion.com, workshops about dealing with specific subjects, and training. Besides, it manages the Certified Data Privacy Professional (CDPP) and the Certificate of Cloud Security Knowledge (CCSK), in Spanish for Spain and Latin America.

The ISMS Forum Spain is registered with the National Register of Associations, Group I, Section I, National Identification Number 588718 (Registro Nacional de Asociaciones, Grupo I, Sección I, Número Nacional 588718). The Association's headquarters are located at Calle Castelló, 24, Madrid, Spain.

#### INTERNATIONAL CONFERENCES OF ISMS FORUM SPAIN

The ISMS Forum Spain organizes two International Conferences about Information Security per year. They are a meeting point for discussion and debate among representatives of all parts engaged in the sector. Their purpose is presenting high level speakers, both national and international, and very relevant and current topics. All of this in a context that makes easier the learning and exchange of experiences among the attendees.

The International Conferences of ISMS Forum have become a reference in the sector. In their 12 editions, 300 lecturers and more than 3,400 attendees have participated.



# SPANISH CYBER SECURITY INSTITUTE

The Spanish Cyber Security Institute (SCSI) promotes knowledge-sharing and collaboration among main actors and experts involved in the sector to boost and contribute to improving Cyber Security in Spain. Therefore, the SCSI carry out an important analytical work (studies), awareness (events) and training (Certification on Cyber Security), among others.

The SCSI wants to raise consciousness regarding the necessity of controlling and management of the Cyber Security risks in the current society of technologies of the information and communications.

# **DATA PRIVACY INSTITUTE**

The Data Privacy Institute gathers all persons and Spanish organizations with responsibilities and interest in the enforcement of the privacy and data protection regulations. It promotes excellence in this area of growing importance, and formation and specialization of its professionals.

The Institute organizes discussion forums on privacy in information security. As well as other activities like work groups and formation courses. It has created the Certified Data Privacy Professional (CDPP), the first Spanish certificate aimed to professionals of privacy.

# **CLOUD SECURITY ALLIANCE**

The Spanish chapter of the Cloud Security Alliance (CSA-ES) gathers representative members of the industry of Cloud Computing in Spain. It consists of a debate forum which promotes the best practices in order to guarantee both the security and privacy in the environment of Cloud Computing, being "Compliance in the Cloud" one of its specific areas of interest.

The ISMS Forum an CSA-ES stimulate the first professional certificate in Spanish on Information Security in Cloud Computing, the Certificate Of Cloud Security Knowledge (CCSK). This CSA certificate has been adapted and updated by the Association so as to promote the specialization of Spanish-speaking security professionals, in Spain and Latin America.

Protegetuinformacion.com is a didactic and interactive tool which divulges the culture of Information Security and Personal Data Protection among citizens. It is addressed to every social group (children, youngsters, adults, elders, parents and professionals).
