The subject matter of the **6th International Conference of ISMS Forum Spain** will focus on the **effects of the global economic crisis, but also the profound social transformation in the use of ICT in the last few years in the Information Security sector.**

Multiple effects of the global economic situation are already being noticed in the sector, and it is likely that more direct consequences of the economic and financial situation in the entire field of Information Security can be observed in the months ahead. **The main ones are:**

- **Increase of cyber crime**, identity theft, hacker attacks, phishing, spam, etc. Increase in the need for forensic analysis, compiling **electronic evidence**, **coordinate with competent authorities** on the subject, etc.
- **Disappearance from the market of firms providing goods and services related to Information Security.** Mergers and acquisitions of firms in the sector.
- **Modification of rates and fees** in the sector.
- **Increase of Information leaks** (stealing of data and other sensible information) **in all kinds of organizations**, and especially those who present redundancy plans) or massive layoffs.
- **Increase of outsourcing** related to Information Security.
- **Budget cuts** on Information Security in companies.

Added to all this, the unstoppable technological evolution and **revolution in the use of the internet** that is causing changes in habits, ways of working and meeting people. Phenomenons like online social and professional networking, or cloud computing imply an unavoidable need to prepare companies and individuals to protect themselves from new threats to the security of their information and personal data.

Once more, with the intention of generating debate and passing on experience from a global perspective to the experts who work in Information Security in Spain, this conference will consist of debates, best practices, and conferences in which **experts and persons responsible for Information Security in Spanish and international companies and institutions will participate.**
